

## Operating capacity and spare capacity

The operating capacity relates to the actual number of places offered which may be different from the maximum number of children a setting is registered for by Ofsted.

Spare capacity is calculated by using the Ofsted registered number minus the actual number of places offered by a provider (operating capacity).

### Places for under 5's

The number of children per place is calculated by dividing the 0–4-year-old population by the operating capacity.

### Places for over 5's

The number of children per place is calculated by dividing the 5–11-year-old population by the maximum Ofsted registration.

## Expansion of the Early Years Entitlements

From September 2025, children of eligible working parents can access 30 hours of early learning and childcare from the term after their child turns 9 months old.

To assess future childcare sufficiency, current supply of places has been compared with estimated demand for the early years entitlements in the summer term 2026. The figures in columns A to D in the table below shows the estimated surplus places or gap based on providers' current operating capacity (places offered) as at summer 2025. The figure in column E is the total number of unused spare places; this is the difference between the Ofsted registered number and the actual number of places offered by providers (operating capacity). The figure in column F is the overall estimated surplus places or gap based on the assumption that all the unused spare places can be utilised.


The projected number of 3 and 4-year-old children has been adjusted to exclude 4-year-olds of reception age as most 4-year-olds start in school reception in the autumn term.



## Notes

**Day nurseries** - in the private and voluntary sector providing all year-round childcare to children aged 0 to 4 years old. Usually open for 10+ hours per day.

**Pre-schools** - extended pre-schools and playgroups providing term time care to children aged 2 – 4 years old. Some offer places to under 2's and most open for 6 hours per day.

**Independent school nurseries** – private schools with a nursery class providing term time care to children aged 2-4 years old. Some offer places to under 2's.

**Out of school** – Before and after school clubs in private providers, voluntary providers, maintained schools and academies.

**Holiday schemes** – operated during school holidays usually for children aged 3-11 years old.

**Maximum capacity Ofsted registration** – the maximum number of children a provider is registered for as stated on their Ofsted registration certificate (full time places). This figure may have been adjusted to take into account local knowledge to more accurately reflect the actual number of registered places as settings can increase the number of children they care for provided they remain within Ofsted’s space requirement guidelines.

**Operating capacity** - the number of places offered in the Summer term 2025.

**FTE** – Full Time Equivalent. The number of places shown in all tables are FTE places.

**One full time place** is equal to 30 hours or more.

**One full time vacancy** is equal to 30 hours or more.

**Vacancies** shown are from the Summer term 2025.

**Quality** – settings with an Ofsted grading of Outstanding, Good, Requires Improvement or Inadequate at their latest published inspection as at 31<sup>st</sup> August 2025. The overall school grading has been used to calculate the quality of school nurseries.

Out of school and holidays schemes are graded ‘met’ or ‘not met’ and are therefore not included.

Some independent school nurseries are registered and inspected with the Independent Schools Inspectorate which inspect under a different framework and therefore inspection grades are not included.

**PVI** refers to Private, Voluntary and Independent childcare providers.

**Under 5’s children per place** is calculated using the 0–4-year-old GP population data, May 2025.

**Over 5’s children per place** is calculated using the 5–11-year-old GP population data, May 2025.

**Two-year-old take-up (families in receipt of support criteria)** - the overall Kirklees take-up percentage has been adjusted to include all 2-year-old children who have accessed the free entitlement in Kirklees, including families eligible to both criteria (working parents and families in receipt of support).

**Three- and four-year-old take up** – 4-year-olds move to reception class in the Autumn term.

**Childcare charges** – NA indicates this information has not been provided.

**Data sources used** - Access Synergy database, Ofsted, School Census January 2025, Early Learning and Childcare Funding Claims and Sufficiency Data collections Autumn 2023 to Summer Term 2025, GP Registration data May 2025.
