BY THIS ORDER

- The footpath over the land shown by a bold black line on the attached map and described in Part 1 of the Schedule to this Order ("the Schedule") shall be diverted as provided below
- There shall be created to the reasonable satisfaction of Kirklees Council an alternative highway for use as a replacement for the said footpath as provided in Part 2 of the Schedule and shown by bold black dashes on the attached map
- The diversion of the footpath shall have effect on the date on which Kirklees
 Council certify that the terms of Article 2 have been complied with
- 4. Where immediately before the date on which the footpath is diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had
- This Order may be cited as the "Kirklees Council Public Footpath Batley 40 Howley Walk, Soothill, Batley (part) Public Path Diversion Order 2021"


