

**HIGHWAYS ACT 1980
WILDLIFE AND COUNTRYSIDE ACT 1981
KIRKLEES COUNCIL (PUBLIC FOOTPATHS KIRKBURTON 145 (PART) AND
KIRKBURTON 186 (PART) AT FOLLY HALL, CROSS LANE, SHELLEY)
PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT
MODIFICATION ORDER 2021**

On 07 June 2023 Kirklees Council confirmed the above order made under section 119 of the Highways Act 1980 and section 53A(2) of the Wildlife and Countryside Act 1981.

The effect of the order as confirmed is to divert that part of public footpath Kirkburton 145 having a width of approximately 1.2 metres and shown on the order plan by a bold continuous line commencing at point A (grid reference SE 2025 1221) and proceeding in an easterly direction for approximately 33 metres to point B (grid reference SE 2028 1220).

The effect of the order is also to divert that part of public footpath Kirkburton 186 having a width of approximately 1.2 metres and shown on the order plan by a bold continuous line commencing at point B (grid reference SE 2028 1220) and proceeding in an easterly then south easterly direction for approximately 80 metres to point C (grid reference SE 2035 1219).

In place of the above mentioned routes will be a public footpath with a width of 2 metres to be known as Kirkburton 186 (part) shown on the order plan by a bold broken line commencing at its junction with footpaths Kirkburton 127 and Kirkburton 145 at point A (grid reference SE 2025 1221) and proceeding in a south easterly direction for approximately 32 metres to a footbridge at point D (grid reference SE 2026 1218) thereafter proceeding in a south easterly then in an east north-easterly direction for approximately 102 metres to point C (grid reference SE 2035 1219).

The order came into force as from 07 June 2023, but if any person aggrieved by the order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the order, he or she may, under paragraph 2 of Schedule 2 of the Act as applied by paragraph 5 of schedule 6 to the Act, within six weeks from 16 June 2023, make an application to the High court.
