**KIRKLEES COUNCIL (KIRKBURTON 257 – FARNLEY BANK WOOD), DEFINITIVE  
MAP MODIFICATION ORDER 2024**

This Order is made by Kirklees Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 (“the Act”) because it appears to that authority that the West Yorkshire Metropolitan County Council Definitive Map and Statement for the Kirklees Area require modification in consequence of an event specified in Section 53(3)(c)(i) namely the discovery by the Authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a footpath.

The Authority has consulted with every local authority whose area includes land to which the Order relates. Kirklees Council hereby order that:

1. For the purpose of this Order the relevant date is 09 November 2023.
2. The West Yorkshire Metropolitan County Council Definitive Map and Statement for the Kirklees Area shall be modified as described in Parts I & II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the “Kirklees Council (Kirkburton 257 – Farnley Bank Wood) Definitive Map Modification Order 2024”.

**PART I - MODIFICATION OF THE DEFINITIVE MAP**

**DESCRIPTION OF PATH OR WAY TO BE ADDED**

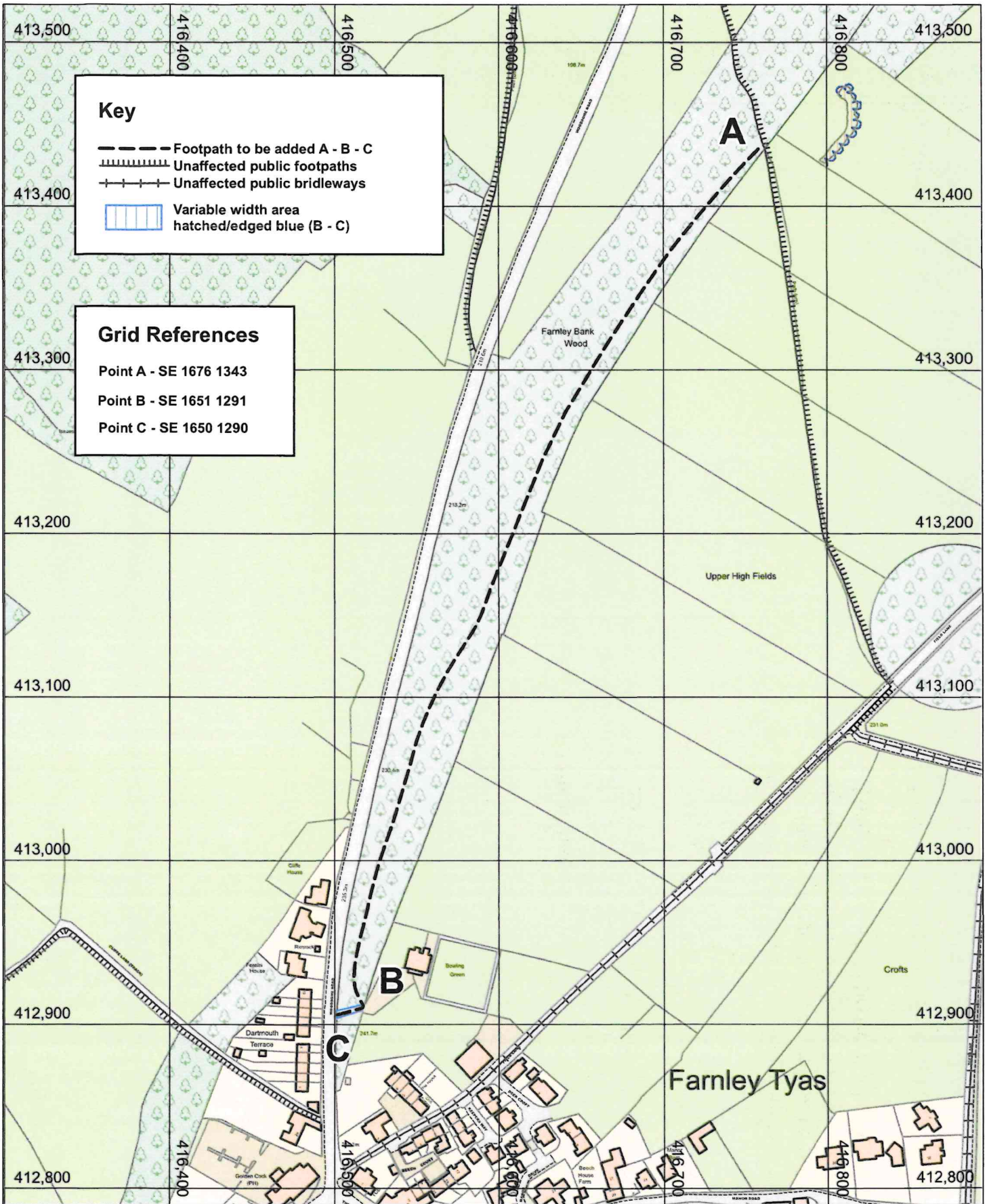
A footpath, as shown on the map annexed hereto by the bold dashed line, at Farnley Tyas, commencing at its junction with path no. 55 at grid reference SE 1676 1343 (point A on the map) and leading generally south-southwest for approximately 600 metres through Farnley Bank Wood with a width of 1.5 metres to its junction with the access road to Farnley Tyas Bowling Club (point B on the map) at grid reference SE 1651 1291 and then leading generally west-southwest for approximately 20 metres with a variable width of 3.8 metres to 4.6 metres within the area hatched/edged blue (point B to point C on the map) to its junction with Woodsome Road opposite no. 8 Dartmouth Terrace at grid reference SE 1650 1290 (point C on the map).
