Matter 31 (Action 77): H764 Land west of Sunningdale Road, Crosland Moor

Inspector's request for note:

• Clarifying whether this site has been tested as part of the Open Space Study. If not, how can paragraph 74 be satisfied.

Council note:

The council can confirm that this site was not been tested as part of the council's Open Space Study 2015 (revised 2016).

However, the council has now undertaken an open space assessment specifically for site H764 9as shown below). This new assessment identifies the site as having medium value as open space based on its use for informal play as part of the wider Walpole Recreation Ground and use of the public footpath as a route to school. On this basis of this new evidence, the council considers there is sufficient justification for the designation of this site as urban green space.

The council therefore propose a modification to delete the allocation of H764 and designate the site as urban greenspace by extending UGS1199.


