## Item 5: Board Membership

#### 1. Introduction

It is a requirement that the Dewsbury Town Deal is formally supported by a Board.

At the meeting on the 19<sup>th</sup> November two actions were highlighted. These were:

- For Council Officers to write to Members who had not attended the Town Board meeting for a considerable amount of time to ascertain whether they wanted to remain on the Board
- To discuss with Bruce Bird the extent of membership of Dewsbury Chamber of Trade and other local bodies.

Officers have actioned both of these requests and can report the outcomes below and the impact it has on overall Membership

#### 2. Board Resignations

Officers have written to two Members who have not attended the meeting or participated in drop in sessions since the beginning (January 2020). These Members: Abdul Aslam and Simon Cash have responded to this communication – by email - and asked to be removed from the Board.

Outside of this exercise officers have received an email of resignation from Carles Palomo – Chemfix.

#### 3. Dewsbury Interest Groups

Discussion has been held with the following presentatives to seek to finalise the best representation on the Board:

- Bruce Bird
- Paul Ellis
- Barney Mynott

As a result of these discussions Officers have been asked to consider the following:

- That Bruce Bird remains on the Board and will represent the Dewsbury Partnership and the Federation of Small Businesses.
- That Barney Mynott and Paul Ellis cease being Members of the Board and are replaced by Martin Walsh who will represent Dewsbury Chamber of Trade

This will be a net loss of one Member.

#### 4. Final Board Membership

The consequence of these changes are that the Board reduces its Membership to 14. It still has a range of representation from all sectors in Dewsbury. The table below sets out Membership
