KIRKLEES COUNCIL (SPEED LIMIT) (NO. 115) ORDER 2022 DUNFORD ROAD, HOLLOWGATE ROAD, LOWER MILL LANE, ROTCHER ROAD, TOWNGATE ROAD, VICTORIA SQUARE, VICTORIA STREET, HOLMFIRTH (20 MPH SPEED LIMIT AND 30MPH SPEED LIMIT)

The Council of the Borough of Kirklees propose to make the above Order under their powers in the Road Traffic Regulation Act 1984 the effect of which, as it affects roads in the Holmfirth area in the Kirklees district, will be to:

i. Impose a 20mph speed limit on the following lengths of road:

1. Bus Station, Holmfirth

On its entire length

2. Dunford Road, Holmfirth

From the junction of Towngate Road for a distance of 10 metres south-eastwards.

3. Hollowgate, Holmfirth

From its junction with Victoria Square to a point 10 metres south-east of its junction with Huddersfield Road.

4. Lower Mill Lane, Holmfirth

On its entire length

5. Rotcher Road, Holmfirth

On its entire length

6. Towngate Road, Holmfirth

From its junction with Station Road to its junction with Victoria Square.

7. Victoria Square, Holmfirth

From its junction with Town Gate to its junction with Hollowgate

8. Victoria Street, Holmfirth

From a point 10 metres south-east of the junction of Huddersfield Road to its junction with Hollowgate.

ii. Impose a 30mph speed limit on the following lengths of road:

1. Dunford Road, Holmfirth

From a point 10 metres south-east of its junction with Victoria Square to a point 110 metres south of its junction with Cross Gate Road.

2. Victoria Street, Holmfirth

From the junction of Huddersfield Road for a distance of 10 metres in a south-easterly direction

iii. This order will also revoke any current speed limits affected by these changes on the above roads.
