KIRKLEES COUNCIL EXPERIMENTAL (TRAFFIC REGULATION) (NO.33) ORDER 2020

Macaulay Street, Upperhead Row, Huddersfield

NOTICE is hereby given that the Council of the Borough of Kirklees has made above Order under their powers in the Road Traffic Regulation Act 1984 the effect of which will be:

- 1 To introduce a no right turn restriction from Macaulay Street to Market Street Huddersfield
- To prohibit driving on Upperhead Row from its junction with Dundas Street in a southerly direction to its junction with Macaulay Street; and to prohibit driving on Macaulay Street from its junction with Upperhead Row in a south easterly direction to its junction with Market Street

At all times for all vehicles except permit holders, cyclists and emergency vehicles and for loading between the hours of 6am to 1pm Monday to Friday inclusive.

- To introduce a one-way traffic flow for all vehicles except cyclists on Upperhead Row from its junction with Threadneedle Street to its junction with Macaulay Street in a southerly direction; and on Macaulay Street from its junction with Upperhead Row to its junction with Market Street in a south easterly direction
- To revoke items in West Yorkshire Metropolitan County Council (Kirklees) (Traffic Regulation) (No.5) Order 1978 First Schedule items 1 & 2 which will be redundant on the making of this Order

The Order will be implemented initially on an experimental basis for eighteen months, after which time it will be reviewed. The Council may then make the Order permanent or abandon it.

REASON: to improve road safety for all road users by the introduction of safeguards to enable safer manoeuvres of service vehicles which are difficult currently; to limit traffic access to those necessary for deliveries; to prohibit loading/unloading on evenings and weekends to allow businesses to apply for café licenses on Upperhead Row.
