Various Roads - Huddersfield Town Centre

The Council of the Borough of Kirklees propose to make the above Order under their powers in the Road Traffic Regulation Act 1984 the effect of which, as it affects lengths of road in the Huddersfield Town Centre in the Kirklees district, will be as follows: -

- Cross Church Street to remove the existing pay and display parking place
- Dundas Street

 north side to create two pay and display parking places measuring 38 metres in length to replace the existing one place.
 - South side to reduce the existing pay and display parking place to 29 metres in length
- Half Moon Street to reduce the existing pay and display parking place to 21 metres in length
- Queen Street to remove the existing pay and display parking place
- Queensgate to remove the existing pay and display parking place
- Upperhead Row to remove the two existing pay and display parking places.
- **NB.** These proposals should be read in conjunction with the other proposals recently advertised concerning these and other roads in Huddersfield town centre.

Statement of Reason for proposing to make the Order

These proposals affecting existing pay and display parking places in various roads in Huddersfield town centre are part of the more extensive changes affecting the town centre associated with the Huddersfield Blueprint, a 10 year vision to create a thriving modern-day town centre designed to improve access to the new Cultural Heart, Kingsgate Shopping Centre and surrounding areas.

The Blue Print proposals will limit parking in areas for specific purposes such as Loading or for blue badge holders for example and in consequence some parking places will be removed and some amended.

It is believed the changes will improve road safety and cyclist and pedestrian connectivity within the town centre.

The Council of the Borough of Kirklees (hereinafter referred to as "the Council") in exercise of it's powers under Sections 45, 46, 47 and 49 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and Part 6 of the Traffic Management Act 2004, the Road Traffic (Permitted Parking Area and Specified Parking Area) (Metropolitan Borough of Kirklees) Order 2006 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act and with those persons and organisations specified in the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 hereby make the following order: -

- 1. This Order shall come into force on the day of 202 and may be cited as the "Kirklees Council (On Street Parking Places) (No. 4) Order 2020.
- 2. Kirklees Metropolitan Council (On Street Parking Places) (Consolidation) Order 2004 as amended is hereby further amended so as to replace the existing items 14a and 14b of the First Schedule with the items specified as items 1a 1c of the First Schedule to this Order and to replace the existing item 19 of the First Schedule with the item specified as item 2 of the First Schedule to this Order.
- 3. The Orders specified in Column 1 of the Second Schedule to this Order are hereby revoked to the extent as is specified in Column 2 of the said Second Schedule.
