





# Projected Number of Three-and Four-Year-Old Children eligible to early learning


The number of children accessing early learning is subject to seasonal variations, the number of three-and four-year-olds eligible to early learning is lowest in the autumn term due to children moving to the school reception year and peaks in the summer term as the cohort increases. The graph below uses the population from GP registration May 2023 to estimate the number of children eligible to free learning over a period of six terms. The table shows the number and percentage change from the same term in the previous year. The figures are intended as a guide only, it is important to note that the data may have changed since publication in May 2023, and the accuracy of forecasts diminish the longer they are projected into the future.


